

TERMS OF USE

One arbitrator appointed under such rules shall conduct arbitration. Any such arbitration shall be in Arlington County, Virginia, and the laws of Virginia shall be applied. Any decision in arbitration shall be final and binding upon the parties. Judgment may be entered thereon in any court of competent jurisdiction. Notwithstanding the above, The Conservation Fund may sue in any court for infringement of its proprietary or intellectual property rights. All claims you bring against The Conservation Fund must be resolved in accordance with this section. All claims filed or brought contrary to this section shall be considered improperly filed.
